If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

(This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Including, but not limited to, staff available 24 hours a day, 365 days a year; consultation with family and responsible parties prior to, during and after the arrangement conference; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; composition and submission of local obituary notice; and coordination with those providing other portions of the funeral (e.g. clergy, cemetery, crematory, vault company and others required). Also included in this charge are overhead expenses relative to our facilities, such as professional licensing, parking lot and grounds, record keeping, and secretarial and administrative expenses.

2. Embalming \$750.00 Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have
